Rules governing the use of the recreational facilities



Rules for all, guarantees everybody's enjoyment!

We provide a recreational area of high standing which includes a heated indoor swimming pool with jacuzzi, sauna, a rinsing shower to be used prior to entering the pool or before entry into the sauna, a changing room with shower and WC facilities.

In order to ensure a maximum amount of safety for every user, to make your stay pleasant and to keep the installations in good condition, guests shall abide by the internal rules governing the use of the recreational area and undertake to abide by the safety and hygiene regulations that are in everybody's interest.

The following rules must be adhered to:-

Any failure to abide by the rules will automatically bring about the exclusion without any prior notice, for the use of the recreational facilities.

1 – Any person who has not signed the present document and handed to the owner will not be entitled to use the recreational facilities (swimming pool and sauna).

To enter the swimming pool or sauna all persons must wear a swimming costume.

- **2** The recreational area is open for use by the guests between 9.00 a.m. and 8.30 p.m. except in the case of a force majeure (bad weather, cleaning, etc). If you wish to swim in the pool outside the above mentioned hours we request that you consult the owners.
- **3** The swimming pool is a private pool belonging to the owners. Its use is reserved exclusively for members of the owner's family, their friends and the guests residing at the "L'intermède" cottage.

The owners remind all persons using the swimming pool and sauna that there is no attendance. As a result all adults over 18 years shall observe the strictest rules regarding safety on behalf of all those under age persons in their care as shown in the contract.

4 – All children below the age of 13 years who are not accompanied by an adult are not allowed, under any circumstances, to enter the recreational area (swimming pool and sauna).

Under age children shall be accompanied by an adult who can swim. We ask you to supervise very young children in particular in order to avoid any risk of accident.

Under no circumstances should children be allowed to remain alone at the pool

If you have children still in nappies and wish them to use the pool they must be fitted with watertight nappies designed for the purpose.

- 5 All persons using the swimming pool shall conform to the following rules:-
 - Take a shower prior to entering the pool and wash their feet in the foot bath. When using the pool especially in the summer period when the patio doors are open, each person shall wash their feet in the foot bath before entering the pool
 - Each bather who has used sun cream or sun oil shall shower prior to using the pool.
 - Remove all footwear when entering the recreational facilities and either walk barefoot or use swim footwear when using the wooden patio area.
 - No object shall be left in the pool that could cause an obstruction to the filtration system or in the automatic pool cleaner. An object which could also attract a child. It is strictly forbidden to bring into the pool

area any object made of glass. Any drinks shall be in plastic tumblers, (see coloured tumblers in the "cottage")

- ◆The door to the recreational area shall be closed after use
- **6** Access to the recreational area is strictly forbidden to persons who are drunk or who are clearly unclean; this includes persons affected with an infectious disease

7 - The following is strictly forbidden

- Night time bathing
- To open the safety shutter when closed: the pool shall be considered closed when the shutter is down.
- ◆ To dive : depth of pool: 1.20 metre 1.70 metre
- To throw or push any person into the pool.
- To use soap or any other similar product in the pool.
- To spray other users of the pool or to send water out of the pool by whatever means « bombing», etc...
- $\bullet \mbox{To}$ scream or organize any violent games at the edge of the pool or in the pool.
- ◆ To spit in or around the pool.
- To throw any object, stone, piece of wood etc. or any object likely to injure a person or damage the pool liner. All equipment that is damaged by the user will be invoiced to those persons considered liable
 - ◆ To run around the edge of the pool when it is wet.
 - It is strictly forbidden to enter the equipment room and to touch any part of the electrical installation.
 - The use of rubber rings and other material admitted in the pool is at the guest's liability.

The recreational facilities are an area for relaxation and calm. Please respect the right to tranquility of other persons using the pool and/or sauna.

- 8 All persons using the pool shall be covered by a liability insurance and acknowledge that the owner's liability shall be excluded in respect of safety measures connected with the monitoring of all those who are part of the holiday group.
- ${f 9}$ If in the case that any of the above rules are not adhered to, the owners reserve the right to withdraw their authorization to use the said facilities and no compensation shall be due.
- 10 The garden furniture available for use by the guests around the pool is provided for use by the guests but for which they shall be liable and as such shall take all precautions to ensure that it remains in good condition.

11 - Use of infrared Sauna

The sauna has a capacity of 4 people. It is strictly reserved for use by adults over the age of 18 years or by under-age people if accompanied by an adult.

IMPORTANT

Safety devices do not in any way replace the presence of an adult person who should show due diligence in monitoring the activities in the area.

All adults shall read and have knowledge of the security provisions for each device.

The safety devices ensure the safety of young children only if the device is locked.

Under no circumstances should you allow a child to remain alone in the pool area, nor leave them alone nor take your eyes off them even for a few seconds: your child could drown in 3 minutes in 20 cm of water.

While bathing in the pool it is strongly recommended to fit children with a floatation device (properly fitted rubber ring, arm bands, ...)

IN THE CASE OF AN ACCIDENT

Take the person out of the water immediately.

If they have become unconscious carry out elementary resuscitation procedures (CPR).

Call the emergency services closest to the address. In the case of drowning speed is of the essence.
